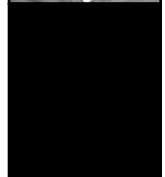

They will also be joining us at the Christmas Party. Again, welcome to our group!



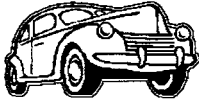
